EVOLUTION OF THEATRE CONCEPTION

(From the ancient epoch including Italian renaissance)

Works, where is illuminated the theatre problematic, such as historical sources, official documents, correspondence of stage experts, reminiscences, scientific researches, or reviews, could be mentioned as a viewpoint expressed in the theatre art. This term is accepted and implemented in the scientific circulation. Achievements of the professional theatre have more stipulated the kind of theatre literature, enthusiasm and research specifics. As it is known, scientists divided the whole process of civilization development into epochs for systemizing of the mechanism intrinsic for this common course. This course was also assumed by the study of art and it also could be used in the study of the theatre.

The group of scientists who revealed the aim of experts' research, subject and research method, has explored 25 century professional theatre evolution period with this natural division. Consequently the theatre art has gained the kind of scientific research-investigation. The research different aspects of theatre art became prerogative of experts for the last quarter of the XIX century. Henceforth the theater literature has enriched with specific research-investigations of this experts (theatre experts). For this time were revealed persons, who rose, developed, made universal and dimensioned the analyses of theater art specific. They systematized traditional forms of research, created modern theatre science with comprehension of empirical method. There was segregated a group which

created a base for study of theater as a priority science of theater art learning. Max Herman's, Arthur Kutcher's and Carl Nicen's activities, discoveries and research achievements have created authority to study of theatre and created this field's university study in Germany.

Thus this work is the part of this research and at the same time is finalized for promotion of this process that is typical for mentioned epochs and creates a base for finding of certain regularity.

Therefore, the entire period, from antique to post-modern epoch, of theatre idea's evolution, can be considered as finding of a certain time, which reflects time flow process.

During the centuries-old history of theatre art, stage creativity has undergone numerous transfigurations. I mean not only the pure art changes, but theatre administration process as well. However, theatres of different epochs

have solved mentioned problems differently, some common sign is still particularly emerged:

1. Theatre, as a public and state institution, has always been in the center of attention of ruling circle, as a universal mean of impact on society;

2. Theatre responded the spirit of the epoch, carried out the ruling elite's orders, was taking into account society's requirements and tried to present, mostly in allegorical reference, the main ideas, important problems and cooperate with the process of creating active civil society with help of active influence on the spectators;

3. With current ideas, aesthetics, philosophical – world-view or with the stage adaptation of actual problems, was refining expressive forms and finding appropriate means of leading trends, thus, was solving creative or administrative – financial and technical issues on the higher phase of development.

I have examined the works by epochs, where is discussed theatre literature; as the research of mentioned problems should begin from the antique epoch, which is enabled by the history of the theatre. Stated and expressed opinion on the Medieval and Renaissance epochs, which achieved us as historical documents, in the compositions of many philosophers', religious person's, writer's or poet's works, is making clear that these two periods are intrinsically related to the antique epoch. "Theatre art was differentiated in the Middle Ages, were created three theatre sightseeing cultures (square theatre, court theatre, church show) and genres as well". Despite the fact that in this period, emphasis was moved to the theatre aesthetics characterized for this epoch, at least partially, was revealed several aspects of the ancient sightseeing culture, ignoring of which is impossible during the analysis of theatre opinion. It was a ritual. The medieval history theatre with its forms of expression, first of all by its ritual, was suffering impact on medieval social life. Thus was established the kind of theatre literature. But Renaissance epoch, assuming even a term, has raised the performing art on completely new level, has used and studied achievements of the antique epoch. Then, the vital space of theatre experienced qualitative changes, accordingly theatre studies as well. That is why

I consider it possible to choose the topic – “Evolution of theatre opinion” – which is the object of perennial research, it will be relied only on the theatre opinion analysis of three epochs (antique, Middle Ages and the epoch of Italian Renaissance including), and where is going its examination with help of creation of certain regularity. At least for the reason, that then is starting qualitative change in the stage art and, consequently, the theatre research is experiencing transformation. During the centuries, different authors studied drama as a genre of literature. Here must be found and built the demarcation line. The examinations, which have been created for study and reflection of the dramaturgy, as one of literature genres, represent the branching of study of literature. The drama as a base for stage art, as dictating information of depiction forms, is by itself the learning object for specialists, and this kind of works are one of the theatre literature’s brunches as well. Drama takes main place in the history of theatre, mainly due to the fact of the drama – “written text” residual. Therefore, the theatre base is fluctuating neither with this, nor with that fact that the brilliant epochs of theatre depiction, often are related to this or that playwright’s activity. However, as we know, theatre science studies verbal act together with visual act, its form of research becomes synthetical. Peter Brook writes that “theatre of every nation and the world’s every continent is guided by mimic expression “material” of all human body - is it “naturalistic” or abstract”. This means that in the theatre performance, it is impossible merging of visual and acoustic expression - dance, music, singing, gesticulation, acrobatics, outfits, masks, speech or decoration, so that all the expression elements are presented – heard in “equal” essence, none of them will be raised on the foreground, not hushed up, so performance of visual - verbal act is of a single integrity. Learning of stage creativity, research of its history, illumination of certain aspects is very complicated, because the ephemerality of scientific research objects less subdues usage of traditional forms in each individual case. History of theatre is the history of performances, shows, entertainment and not history of drama, which is only the part of theatre history as a history of actor’s art, theatre art, theatre music, theatre costumes and even the history of the theatre building. Mimic expression is in every kind and epoch of theatre birth, which is

often accompanied by verbal acts as well. Ancient form of such expression should be found in the intelligent expression of the human's "not fettered" sensitiveness, which from the beginning appears in each epoch or tribe, people, or nation. Aristotle was sharing view that "the game and strive to the mimesis belongs to earlier and the most elementary excitation of the spirit". According to the development history it is older than religion. Thus, studying the literature of theatre is impossible without taking into account this objective resistance. As research object defines means of its study, during centuries it becomes appropriate for theatre literature and there expressed opinions to use significant forms for researches of different experts. This process continued even after, was revealed the modern study of theatre and forms of its research.

Study of theatre, as learning field of theatre art, is studying stage art by three constituent parts: history, theory and theatre criticism. Theatre literature is also created by historians, theorists and critics of the theatre. If we peer into the whole process of theatre literature development, there will be also clearly revealed one significant aspect: theater research and opinion about theatre have characteristically changed after appearing of theatre examining experts on the acting field. This new phase is related to the appeared event at the turn of the XIX and XX century, when the whole generation of modern theatre experts appeared on the acting field. As is known, the term Theatre Science was introduced and inculcated in scientific or practical circulation by Max Herman. Modern study of theatre has characteristically changed the aim of study – research, research subject and also found the research method. The performance, but not drama, was recognized as a research subject, and as I think "reconstruction process" discovered by Max Herman is the most optimal method from the methods found by scientists.

According to William Kinderman,¹ theatre science has relation to folklore, religion – mythology, music and dance history, politics, sociology, psychology, aesthetics, philosophy, technology, archeology and philology; I would also add the scientists' modern exact and humanitarian findings. Hence

the whole way, from antique period to post-modern epoch can be considered in two stages:

I. Theatre literature and opinions expressed in it, which was created from the beginning to the end of XIX century;

II. Subsequent period of modern theatre experts' appearing on the acting field. In addition, theatre literature, its centuries-old achievements, can be divided into three kinds:

I. Literature, which was created by representatives of different specialties: priests, philosophers, bishops, historians, literary men, writers, psychologists, sociologists and different representatives of exact and humanitarian science.

II. Literature, which was created by masters of the stage: actors, stage directors, artists, musicians, etc.

III. Literature, which was created by theatre experts.

Theatre literature has saved forms of kinds, generally typical for literature thinking: theoretical discussions, outlines of theatre history, essays, remembrances, interviews, sociological studies, research of stage art, made by psychologists, etc. "In the beginning of art was not scientist but, an artist"² – wrote Otto Brahm. Hence, firstly must be reflected the way of creation-development of theatre works of art, so based on it, making possible creation of certain theoretical regularity. This for its part makes it clear that the way of creation-development of theatre art performances, "theatre history is part of the theatre science and not vice versa... It is not the goal, but only the way to the goal, one means. It teaches us theatre, stage, actor's art and technique of all times and peoples". Thus, for the first time we must outline, only in the main traits, the way of creation-development of theatre art performances, based on it making possible creation of theatre regularity's theoretical basics in the framework of today's level of theatre science.

Accordingly, the evolution of theatre opinion can be defined by two stages and three kinds. Farther, theatre literature, in which is "knitted" the opinion of this or that epoch, might be also divided into the following types: overview, proper restoration-analysis of the stage examples, theoretical discussions.

Teatr konsepsiyasının təkamülü (İtalyan İntibahı da daxil olmaqla qədim dövrdən bəri)

Tarixi mənbələr, rəsmi sənədlər, teatr mütəxəssislərinin yazışmaları, xatirələr, elmi araşdırmalar və ya resenziyalar kimi teatrın problemlərini əhatə edən əsərləri teatrşünaslıq elmi nöqteyi-nəzərdən ifadə olunmuş resurslar kimi qəbul etmək olar. Peşəkar teatrın nailiyyətləri daha çox teatr ədəbiyyatının növünü, tədqiqat şövqünü və spesifikliyini müəyyən edir. Məlum olduğu kimi, alimlər bu ümumi istiqamətə xas olan mexanizmi sistemləşdirmək üçün sivilizasiyanın bütün inkişaf prosesini dövrlərə bölmüşlər. Bu istiqaməti sənətşünaslıq da öz üzərinə götürmüşdü və ondan teatrşünaslıqda da istifadə oluna bilərdi. Mütəxəssislərin tədqiqat məqsədini, tədqiqat predmetini və metodunu müəyyən edən bir qrup alim bu təbii bölgü ilə 25 əsrlik peşəkar teatrının təkamül dövrünü araşdırıb. Nəticədə, teatrşünas təhlili elmi tədqiqat forması almışdır. Teatr sənətinin müxtəlif aspektlərinin öyrənilməsi 19-cu əsrin son rübündə mütəxəssislərin ixtiyarına verildi. O vaxtdan teatr ədəbiyyatı bu mütəxəssislərin (teatrşünasların) konkret araşdırmaları ilə zənginləşmişdir. Bu dövrdə teatr sənətini genişləndirən, inkişaf etdirən, təhlilini universallaşdıran və müəyyən meyarlara tabe edən konkret şəxsiyyətlər meydana gəldi. Onlar tədqiqatın ənənəvi formalarını sistemləşdirdilər, empirik metodu mənimsəyərək teatr haqqında müasir elmi yaratdılar. Teatr sənətini öyrənmək üçün prioritet elm

kimi teatrın öyrənilməsinə zəmin yaradan bir qrup alim meydana çıxdı. İnkişaf qanunlarına uyğun olaraq dünya teatr sənəti vahid sistemli mövcud hadisə kimi “sadə” formalardan, o cümlədən müasir konseptual rejissor teatrının tapıntılarından başlayaraq, səhnə yaradıcılığının bir növündən daha mürəkkəb mərhələyə “köçmüş”, teatr sənətinin efemerliyinə baxmayaraq, hətta arxetipik dünyası haqqında müəyyən məlumatları özündə saxlamışdır. Bu material sayəsində iki minillikdən artıq bir müddətdə dünya peşəkar teatrının sivilizasiyanın inkişafında mühüm rol oynadığı teatr genezisi haqqında danışmaq olar. Əgər teatrın tarixini dövrlərə bölürüksə, teatr haqqında elmi ədəbiyyatı da bu şəkildə öyrənmək olar.

**Эволюция театральной концепции
(С античной эпохи, включая итальянское Возрождение)**

Резюме

Работы, освещающие проблемы театра, такие как исторические источники, официальные документы, переписка театральных деятелей, мемуары, научные исследования или рецензии, можно рассматривать как ресурсы, выражающие точку зрения театроведческой науки. Достижения профессионального театра в большей степени обусловили вид театральной литературы, энтузиазм и специфику исследований. Как известно, ученые разделили весь процесс развития цивилизации на эпохи для систематизации механизма, присущего этому общему направлению. Это направление также предполагалось искусствоведением и его также можно было использовать в изучении театра.

Группа ученых, выявивших цель исследования, предмет и метод исследования, анализировала период эволюции двадцати пяти векового профессионального театра с этим естественным разделением. В результате театроведческий анализ приобрел вид научного исследования. Исследование различных аспектов театрального искусства стало прерогативой специалистов в последней четверти XIX века. С этого

времени театральная литература обогатилась конкретными исследованиями-разысканиями этих специалистов (театроведов). За это время были выявлены личности, которые подняли, развили, сделали универсальным и размерным анализ театального искусства. Они систематизировали традиционные формы исследования, создали современную театральную науку с пониманием эмпирического метода. Выделилась группа, которая создала базу для изучения театра как приоритетной науки изучения театального искусства.

Согласно законам развития, мировое театральное искусство как существующее событие с единой и подающей системой, начиная с «простых» форм, включая находки современного концептуального режиссерского театра, «двигалось» от одного вида сценического творчества к более сложной фазе, и, несмотря на эфемерность театального искусства, оно даже сохранило определенную информацию о своем архетипическом мире. Благодаря этому материалу можно говорить о виде театального генезиса, благодаря которому мировой профессиональный театр играет важную роль в развитии цивилизации на протяжении более двух тысячелетий. Если историю театра можно рассматривать по эпохам, то этот же подход можно использовать и для научно-театральной литературы.
