## **THE FORMATION AND DEVELOPMENT PROCESSES OF UZBEK MUSICAL THEATER**

**Summary:** This article presents a scholarly analysis of the historical stages of the formation of Uzbek musical theater, its role in the national theatrical system, and the dynamics of its development. The study examines the first musical stage traditions that emerged in the early 20th century, including folklore and ethnographic performances, the art of maqom, and the influence of customs and traditions on theatrical art. In particular, it notes that one of the traditional Uzbek musical dramas, “Tohir and Zuhra” by playwright Sabir Abdulla, has become an important part of the theatrical repertoire. Concurrently, the theatrical interpretation and production of “Nurkhon”, one of the oldest musical stage works dedicated to historical figures, the epic poem “Gorogli”, and the romantic heroic aspects of the musical drama “Ravshan and Zulhumor”, based on folk tales, are examined.

**Key words:** Uzbek musical theater, formation processes, national theatrical art, folklore traditions, maqom, musical dramaturgy, professional theater, contemporary stage art, development of directing.

The Uzbek people have embraced almost all forms of world theater culture. However, relying on their distinctive national character and traditions, they created a new, unique type of professional theater – the musical drama. The history of musical drama goes back a long way. Indeed, for millennia, our people have loved and cherished art, particularly theatrical art. Traditional theater, folk and maqom music, epic performance (bakhshi art), khafiz singing, instrumental music, and dance have all been developing since ancient times. From the second half of the 19th century, European theatrical methods were introduced to our country. The new European-style theater art, combined with our traditional theater, bakhshi performance techniques, maqom, and folk songs

and melodies, gave rise to a musical theater genre unlike any other in the world. This genre became one of the most beloved art forms among our people. At the beginning of the 20th century, unparalleled classic works such as “Halima” and “Farhod and Shirin” were created, laying the foundation for the formation of the distinctive traditions of modern musical theater.

At the beginning of the 20th century, the emerging Uzbek theater, during its development, not only produced dramatic works but also fostered the formation of the musical drama genre, which paved the way for the establishment of a specialized musical theater. Musical performances such as “Halima”, “Farhod and Shirin”, and “Layli and Majnun” were not only foundational in the formation of the musical drama genre in the history of Uzbek theater but also played a crucial role in the establishment of the State Musical Theater of the Republic. In early 1929, based on the “Ethnographic Ensemble” organized by Muhiddin Qoriyoqubov, the “Uzbek State Musical-Experimental Theater” was founded. By November of the same year, it became the “Uzbek State Musical Drama Theater”.

One of the most famous Uzbek traditional musical dramas staged in 1941 was “Tohir and Zuhra” by the playwright Sobir Abdulla. “Tohir and Zuhra” became a work that defined the image, prestige, and value of the newly established theater. The play remained a permanent part of the theater’s repertoire [6]. The music for the work was composed by Tokhtasin Jalilov and G. Shperling. “Tohir and Zuhra” became one of the works that defined the image, value, and significance of the newly established theater. When mentioning the Muqimi Theater, audiences immediately envisioned the performance of “Tohir and Zuhra”. The roles of Zuhra were famously performed by Shahodat Rahimova, E’tibor Jalilova, and Farog‘at Rahmatova, and Tohir by Mashrabjon Yunusov and Mahmudjon G‘ofurov. The performers themselves elevated the fame of the work and its impact on the audience. This popularity even attracted the attention of film specialists, and in a short time, “Tohir and Zuhra” was adapted for the screen.

“Tohir and Zuhra” became a staple of the theater’s repertoire. Several of its songs and melodies left a deep impression on the audience, and the piece “To‘ylar Muborak” quickly became a popular celebratory song, sung in praise of brides and grooms, and rapidly entered the collective memory of the people.

As musical drama and comedy theater were still relatively new, these performances provided broad opportunities even for actors primarily working in

dramatic roles. In “Tohir and Zuhra”, Asad Ismatov gained recognition for his portrayal of Qorobotir, and Abdurauf Boltayev for his interpretation of Khon Bobokhon. The production featured extensive choral and dance sequences, characteristic of the musical drama genre. This work tested the majority of the theater’s acting troupe in performing musical drama roles. For many actors, performing as Tohir or Zuhra on stage was a cherished aspiration, and participating in “Tohir and Zuhra” had become a dream for the performers and a highly anticipated experience for the audience.

Sobir Abdulla’s drama “Tohir and Zuhra” is built upon the people’s long-standing struggle for truth, justice, freedom, and human love in the distant past. The work is based on legendary and tragic human destinies [5]. One of the earliest musical stage works dedicated to historical figures is “Nurxon”, which has continued to captivate audiences across generations. The work stands out for the richness and realism of both its narrative and musical composition. The playwright Komil Yashin, along with composers Tokhtasin Jalilov and Gabdurahim Sobitov, created “Nurxon”, which is considered one of the masterpieces of Uzbek musical theater. It was first staged in 1942 at the Muqimi Theater, with the music performed by an ensemble of Uzbek folk instruments. In its second revision, from 1952 onwards, it was performed with a symphony orchestra. The plot of the work is set in Margilan at the end of the 1920s and portrays the tragic figure of Nurxon Yoldoshkhodjaeva, one of the first women to step into the world of theater. In the performance, there is no sharp distinction between musical numbers and dialogue. Songs, yallas, arias, vocal ensembles, and mass choral scenes each perform their independent roles while contributing to the formation of a coherent musical system. The performance begins with a short introductory piece before the curtain rises. This introduction consists of two contrasting musical themes: one represents the charming, lyrical figure of Nurxon, while the other expresses the character of Khoji with menacing tones. These two musical motifs recur throughout the entire performance, resonating through the symphony orchestra and narrating the unfolding events on stage.

The performance begins with the charming aria of Haydar and the lyrical song of his sister, Qumrixon. The setting is beautifully conveyed – the early morning and the garden scenery inspire Qumrixon’s song, inviting the audience into an atmosphere of elegance and refinement. To enhance the musical effect, the orchestra imitates the sounds of birds, including nightingales, in harmony with the song, enriching the emotional impact of the performance.

The main characters in the performance “Nurxon” possess distinctive musical portraits, with particular attention given to the character of Nurxon. In addition to her solo songs and arias, she participates extensively in various ensemble and mass-choral scenes. For example, in the first scene, Nurxon’s song “Assalom, esonmisiz, donno yigit” addressed to her beloved Haydar, as well as her duet with Haydar and her grand aria composed along her vocal lines, display a unique inner musical coherence. This continuity in musical expression can also be observed in Nurxon’s subsequent songs and arias throughout the performance. In contrast, her second major aria in the second scene, performed with the “Dugoh” maqom intonations, conveys her sorrow and anguish, revealing the depths of her emotional turmoil. Haydar’s musical characterization differs somewhat from Nurxon’s. His musical persona is primarily expressed through lyrical, romantic songs. A clear example is his impassioned and expressive aria “Rabbano dodimga yet”, which demonstrates his lyrical and emotional musical identity.

In the performance, Nurxon’s fate is not merely a personal matter. She rises to the level of a courageous individual who, guided by freedom, enlightenment, and her love for art, remains steadfast on her path even in the face of death. In the final scene, during the mass-choral mourning song, soft tones of light gradually appear. Over the body of Nurxon, tragically killed by Hoji and Mamat, her musical mentor addresses the people, proclaiming with confidence and resolve: “Nurxon’s courage will live forever in the hearts of the people, and in the future, hundreds of Nurxons will emerge in Uzbek art.”

This highly artistic and ideologically rich work captivated audiences with its meaningful content and cohesive musical dramaturgy.

By the 8th century, the Muqanna uprising against the Arab invaders began, a movement known as the “White Robes.” Based on these historical events, the prominent writer Hamid Olimjon created the musical drama “Muqanna” (1944), which vividly portrays the heroic qualities of the peoples of Central Asia.

The creators of “Muqanna” were well-versed in stage conventions and succeeded in producing a performance that was both engaging and appealing to the audience. The main characters – Muqanna, whose real name is Hashim ibn Hakim, his wife Gul Oyim, and the Arab commander Said Battol – are portrayed as lively and realistic figures. The composers crafted music that effectively revealed the personalities of the characters, creating musical episodes, arias, duets, and choral pieces. Because the musical foundation of the work is imbued

with a national spirit and closely tied to its content, the entire piece forms a unified artistic whole.

Regarding the musical portrayals of Muqanna and Gul Oyim, in the first scene Muqanna appears as a wise and altruistic young man, devoted to the welfare of the people. His songs and arias prominently display the grandeur characteristic of folk melodies and maqom traditions. The work makes effective use of classical maqom modes, such as “Savti Ushshoq” and “Mustahzodi Navo”. In the second scene, depicting the struggle against the Arab invaders, Muqanna is portrayed as a lyrical hero. His love for his homeland and for Gul Oyim is reflected in musical episodes and arias, one notable example being based on the famous melody “Samarqand Ushshog‘i”.

Choral songs and vocal ensembles also play a significant role in “Muqanna”. They help to vividly and emotionally express the inner feelings of the characters as well as the events of the plot. For instance, in the second scene, the chorus sung from the perspective of the Arab troops, along with the trio performed by Gul Oyim, Gulobod, and Otash in the “Mug‘ulchai Segoh” mode, exemplifies this function.

In the dramaturgy of the performance, the symphony orchestra was also assigned a significant role. Of the 70 musical numbers in the production, 30 function merely as instrumental interludes (background music). The use of these musical interludes helped to maintain the consistent dramaturgy of the work and created a unified system where words and music were harmoniously integrated.

In the repertoire of Uzbek musical theater, musical dramas based on folk epics and fairy tales occupied a more prominent place than autobiographical, domestic, or political musical comedies and dramas. Musical dramas adapted from epics and fairy tales drew considerable interest from the public, reflecting the fact that over millennia, Uzbek oral tradition had produced a wide variety of epics and tales in many themes, both large and small, including heroic epics. These works prominently conveyed patriotic ideas and depicted selfless, courageous heroes. Through these orally transmitted epics and tales, the cultural and spiritual values of the Uzbek people have been preserved and celebrated from generation to generation.

The musical drama “Ravshan and Zulkhumor”, based on the epic “G‘orog‘li” and other folk tales, was staged in 1957 at the Muqimi Musical Theater. Like traditional musical performances inspired by legends and epics, it was eagerly received by audiences. The character of Ravshan was portrayed by

Mahmudjon G'ofurov, and Zulkhumor by E'tibor Jalilova and Farog'at Rahmatova, both embodying the spirit of romantic heroism. The performance achieved great success, not only in Tashkent but also in 1959, when it was presented on the stage of the Kremlin Theater in Moscow during the Decade of Uzbek Art and Literature. The work was also staged in regional theaters. Among these, the Fergana Theater's production stood out for its mature performances, with Murodjon Ahmedov as Ravshan and Hafizaxon Ibrohimova as Zulkhumor, whose portrayals became widely celebrated among the public.

In the story, the people of Chambil celebrate the eightieth birthday of their beloved hero, the wise and just G'orog'li. Addressing his young men, he calls them to fight against the cruel King Qoraxon. Qoraxon's envoy, Kosadov, delivers a letter to G'orog'li, proposing surrender without battle. During the fight, Qoraxon's soldiers retreat toward Shirvan. On the battlefield, G'orog'li's grandson, Ravshan, demonstrates his swordsmanship as a young warrior. In the course of combat, a soldier is struck on the head by Ravshan's sword, causing his iron helmet to fall and his hair to scatter. This soldier turns out to be Qoraxon's daughter, Zulkhumor. Ravshan instantly falls in love with her at first sight. Zulkhumor gifts Ravshan a golden ring and her cap before mysteriously disappearing from view.

Ravshan, unable to find peace due to his feelings of love, sets out on a journey to search for Zulkhumor, obtaining permission from his grandfather, G'orog'li. Along the way, Ravshan confronts resistance from Qoraxon and encounters the mother of six young men who were killed, now left weak and grieving. The mother listens to his story with sorrow and anger, and promises to have a son. She tells Ravshan of her suffering: "The cruel and greedy Qoraxon sends his daughter to the market to enchant foreign princes and lure them into a trap." [1].

Ravshan goes to the market disguised as a dervish, guarded by the warriors Ersak and Tersak. Zulkhumor does not recognize him in his altered appearance. Ravshan climbs over the wall into Qoraxon's palace garden, causing the palace maidens to raise an alarm. He asks Qoraxon's second daughter, Oqqiz, to give the ring to Zulkhumor. Oqqiz tries to hide the ring, but Zulkhumor notices it. She puts on the ring and quickly summons Ravshan to her. They meet, and Zulkhumor agrees to marry him. She dresses Ravshan in fine, valuable clothing.

Oqqiz quickly informs Qoraxon through her servants, and he orders Ravshan imprisoned. Secretly entering the dungeon, Oqqiz admits she has fallen

in love with Ravshan and says, “If you marry me, I will free you from the prison.” [1]. However, Ravshan rejects her offer, and his father also refuses Zulkhumor’s request. When Zulkhumor attempts to stab herself in the chest, Kosadov intervenes and prevents her. Qoraxon, realizing Ravshan is G’orog’li’s grandson, promises, “If you help me in the war against G’orog’li, I will give you my daughter” [1], but Ravshan refuses. The warriors Ersak and Tersak disguise themselves in palace guard uniforms, awaiting G’orog’li’s arrival. Zulkhumor sends a letter to Ravshan. Kosadov tries to seize Ravshan with a mace, but Ravshan, freed by Tersak, strikes Kosadov down with the very mace, inspiring the people to rise in rebellion. G’orog’li arrives with his soldiers, and Qoraxon surrenders. The victorious people celebrate their freedom, and Ravshan and Zulkhumor hold a joyful wedding.

In this performance, songs, arias, and musical numbers are closely connected to the Uzbek folk musical heritage, such as “Alpomish”. Importantly, the music and arias are thoughtfully integrated and play a significant role in the overall dramaturgy. For example, Ravshan’s aria “Qaydin Kelding,” composed by T.Jalilov, is based on folk songs from the Khorezm region.

In “Ravshan and Zulkhumor”, in addition to the arias, duets, choral numbers, and dances also play a prominent role. The chorus often complements the main characters’ arias and duets according to the situation. At times, it remains in the background, reflecting and responding to the events on stage. Another example is the choral songs performed during the celebration of G’orog’li’s grand wedding, which resonate as a popular festivity and a majestic hymn. Overall, in the “Ravshan and Zulkhumor” performance, music plays a role as important as the literary text. All musical segments are thoughtfully incorporated, distinguished by their national spirit and expressive power.

In general, the musical drama genre that emerged in the 1920s-1930s with performances such as “Halima”, “Farhod and Shirin”, “Layli and Majnun”, “Gulsara”, and “Tohir and Zuhra” was based on the traditional monophonic musical heritage of the Uzbek people, as well as on polyphonic works. By the 1940s, efforts to further develop the musical drama genre had advanced significantly. Musical dramas such as “Davron ota”, “O‘zbekiston qilichi”, “Nurxon”, “Qurbon Umarov”, “Oftobxon”, and “Muqanna”, while also grounded in folk musical heritage, were composed in a polyphonic style and performed with a symphonic orchestra. Within a short period, the national musical drama genre in Uzbekistan was fully formed and flourished. In these

stage works, all the structural components of musical drama were embodied: literary foundation, various forms of musical art, dance, artistic stage decorations, and stage movements – all integrated through a masterful and organic synthesis. This process gave rise to the main characteristics of the Uzbek national musical drama genre. Each musical stage work also possesses its own unique internal features. They cannot be placed into a single uniform mold, because elements such as musical forms, stylistic movements, construction of musical dramaturgy, and musical language depend on the composer's creative level, experience, skill, and philosophical outlook. Therefore, the genre characteristics of each musical stage work are determined by the scope of the features mentioned above and distinguished by its own style. This is why musical dramas and musical comedies are considered complex, composite genres in theater art. The poetry in these works, intimately connected to music, independently advances the dramaturgy of the performance. Unfortunately, this high standard is often overlooked in theaters, especially in regional theaters, and by certain individual creators. They treat the dramaturgical work as the primary element, giving it priority while paying less attention to music. As a result, the dialogue dominates, music takes a secondary role, and a complete, independent musical stage work cannot be realized. Consequently, many stage works quickly fall out of the repertoire.

The national traditional musical dramas mentioned above have had an unparalleled significance as prototypes for contemporary musical dramas. Following these stage works, numerous talented Uzbek dramatists, composers, conductors, directors, ballet masters, choirmasters, singer-actors, and dancers have gained recognition. They have made a significant contribution to the creative development of Uzbek musical theater and continue to achieve artistic successes to this day. All the works listed above represent achievements of the Uzbek national traditional musical drama. However, alongside these achievements, several challenges remain. The most important of these is that, in addition to creating performances based on the national musical heritage, Uzbek composers must collaborate closely with dramatists to fully reveal the essence and roots of each work, creating original music in harmony with the drama. All of the traditional musical dramas mentioned above were created in this way. For this reason, they are rightly regarded as “classic examples of musical drama”. In the future, reviving and further developing these traditions will undoubtedly give new impetus to the evolution of musical dramas.

## Matluba İsoqova Komil qızı ÖZBƏK MUSIQİLİ TEATRININ FORMALAŞMASI VƏ İNKİŞAF PROSESİ

**Xülasə:** Bu məqalədə özbək musiqili teatrının formalaşmasının tarixi mərhələləri, onun milli teatr sistemindəki rolu və inkişaf dinamikası elmi şəkildə təhlil olunur. Tədqiqatda XX əsrin əvvəllərində meydana gəlmiş ilk musiqili səhnə əənələri, o cümlədən folklor və etnoqrafik tamaşalar, maqom sənəti, adət və əənələrin teatr sənətinə təsiri araşdırılır. Xüsusilə qeyd olunur ki, dramaturq Səbir Abdullanın "Tohir və Züxrə" əsəri əənəvi özbək musiqili dramlarının mühüm nümunələrindən biri kimi teatr repertuarının vacib hissəsinə çevrilmişdir. Bununla yanaşı, tarixi şəxsiyyətlərə həsr olunmuş ən qədim musiqili səhnə əsərlərindən biri olan "Nurxon"un teatr yozumu və səhnələşdirilməsi, "Goroğlu" dastanı, həmçinin xalq nağılları əsasında yaradılmış "Ravşan və Zülhumor" musiqili dramının romantik-qəhrəmanlıq xüsusiyyətləri təhlil edilir.

## **ПРОЦЕССЫ ФОРМИРОВАНИЯ И РАЗВИТИЯ УЗБЕКСКОГО МУЗЫКАЛЬНОГО ТЕАТРА**

**Резюме:** В данной статье представлен научный анализ исторических этапов формирования узбекского музыкального театра, его роли в системе национального театрального искусства и динамики его развития. Исследование рассматривает первые музыкальные сценические традиции, возникшие в начале XX века, включая фольклорные и этнографические представления, искусство макама, а также влияние обычаев и традиций на театральное искусство. В частности, отмечается, что одна из узбекских традиционных музыкальных драм, «Тохир и Зухра» драматурга Сабира Абдуллы, стала важной частью театрального репертуара. Одновременно изучаются сценическая интерпретация и постановка «Нурхона», одного из старейших музыкальных сценических произведений, посвященных историческим личностям, эпической поэмы «Горогли», а также романтические героические аспекты музыкальной драмы «Равшан и Зулхумор», созданной по мотивам народных сказок.
